This Annual Report marks the conclusion of WINS' third full year of operations. WINS is increasingly recognised as an important element of the security architecture, providing a complementary value to the

essential regulatory work of states and to the system of authoritative guidance of the International Atomic Energy Agency. The importance of our work is validated by the broad participation of professionals from industry, academia and governments in our workshops, the development and well documented use of our Best Practice Guides and by a continuously expanding membership. We are proud of what has been achieved.

But we are fully aware that our work is not done. The need to promote security leadership, training, vigilance and best practice remains an ongoing challenge. As the 2012 Nuclear Security Summit in Seoul will show, while much has been achieved, much more needs doing to safeguard the world from a nuclear security failure of potential catastrophic consequence. Our task remains urgent.

In recognition of the global scope of our mission, WINS is pleased to welcome to its Board prominent leaders in the international community, Chaibong Hahm of the Republic of Korea, former Ambassador Nobuyasu Abe of Japan. We thank them for joining in this vital endeavour.

We applaud our Executive Director Roger Howsley and our outstanding professional staff for all their labours and for their exceptional achievements.

Ambassador Nobuyasu Abe

Ambassador Abe, who joined the Japanese Foreign Service in 1967, is an accomplished diplomat with a wide experience in the field of arms control and disarmament. Nobuyasu Abe currently serves as the Director of the Center for the Promotion of Disarmament and Non-proliferation (CPDNP) Japan Institute of International Affairs (JIIA).



Hahm Chaibong

Dr. Hahm Chaibong is the Director of the Asan Institute for Policy Studies (AIPS) in Seoul, Korea. The Asan Institute for Policy Studies was founded with a mission to become an independent think tank that provides effective policy solutions to issues which are critical to Korea, East Asia and the rest of the world. The Asan Institute was founded by Chung Mong-joon, who still serves at the Honorary Chair.



Duncan Hawthorne

Mr. Hawthorne is the President and Chief Executive Officer of Bruce Power, the largest independent power generator in Ontario, Canada. Mr. Hawthorne is the Past Chairman of the Canadian Nuclear Association, a member of the Board of Directors of the Ontario Energy Association and current Chairman of the Board of Governors of the World Association of Nuclear Operators (WANO) – Atlanta Centre.



Nancy Jo Nicholas

Ms. Nicholas is a senior member of the Institute of Nuclear Materials Management and served as INMM President from October 2006 through October 2008. She is the Director of Nuclear Nonproliferation and Security Programs at Los Alamos National Laboratory responsible for executing a \$450M Nuclear Nonproliferation and Security Programme annually.



William H. Tobey

Mr. Tobey is a Senior Fellow at the Belfer Centre for Science and International Affairs and was previously Deputy Administrator for Defense Nuclear Non-Proliferation at the National Nuclear Security Administration, where he managed the U.S. government's largest program to prevent nuclear proliferation and terrorism.



It is my pleasure to report on the progress made by WINS during 2011 which marked our third year of operation.

Over the past three years, we have published 25 International Best Practice Guides on Nuclear Security Management and held the same number of International Workshops on five continents to support the development of the Guides and share best practice. We have also grown the WINS membership, both Corporate and Individual, to almost 900 in 62 States and increased our funding base from four to nine organisations, and thank them all.

In March 2012, the Republic of Korea will host the next Nuclear Security Summit in Seoul and we were asked to join the International Advisory Committee for the Nuclear Industry Summit. We will be launching our Compendium of Best Practices for Nuclear Security Management at the event, and were delighted to work with Moleskine[®] in Milan on the production of the Compendium, which will make a tangible and high quality contribution from WINS and our members to the Summit. We have continued to develop our website and its functionality and now provide publications in eight languages, having recently added Korean to the range of languages available. The website also allows members to comment on-line about the Guides and to upload additional materials to help develop the Guides further.

We ask our members at every WINS event, and during the Annual Membership Questionnaire, what they think about our work and its value. I am pleased to report that the positive ratings remain high with 99% expressing their satisfaction regarding the organisation of the workshops and almost 86% of members reporting that they have modified their approach to nuclear security management as a result of their interactions with WINS. The latter figure is what matters most; WINS is making a difference when it comes to implementing "best" security practices. And we are occasionally asked what we mean by "best practice" – does this mean most expensive practice? The answer is no; the guiding criteria that we use are:

- **IMPACT/EFFECTIVENESS:** The practice has demonstrated impact, applicability, and benefits to the nuclear security programme.
- **EFFICIENCY:** The practice has demonstrated cost and resource efficiency where the expense is appropriate to the benefits.
- DEMONSTRATED SUSTAINABILITY: The practice shows sustainable benefits and/or is sustainable within nuclear and related organisations.
- **COLLABORATION/INTEGRATION:** The practice builds effective partnerships among various organisations and integrates security with other functions such as nuclear safety, emergency planning and design.

In some ways, 2011 marks the end of our Foundation Period, which was focused on the production of a suite of value-adding publications to support effective nuclear security management. From 2012, we will concentrate on how best to develop professional development materials that allow practitioners to take accredited courses that are recognised for their quality, efficiency and relevance; we will do this through the launch of the WINS Academy, the details of which will be developed in the months ahead.

Finally I should like to thank the WINS Board for its strategic guidance and to the small and dedicated team of WINS staff and contractors that work tirelessly to achieve the stretching targets that we set for ourselves and for the WINS community; effective and efficient nuclear security remains an essential prerequisite for the industry, society and the environment.


In total, over 600 people attended our events, almost all at their own expense.

ROUNDTABLE ON THE FUKUSHIMA TRAGEDY

Time for an Integrated Approach to Nuclear Risk Management, Governance and Safety/ Security/Emergency Arrangements

We hosted a one-day roundtable discussion focused on the early lessons emerging from the Fukushima tragedy that occurred in Japan in March 2011. The roundtable, which was co-hosted by Serco, was held in London on the 12th May at the Royal United Services Institute for Defence and Security Studies (RUSI). As a result of this roundtable, WINS produced a paper setting out the priorities for nuclear security which will contribute to the international debate on what needs to change to improve the management and oversight of nuclear operations.

INTERNATIONAL BEST PRACTICE GUIDES

WINS published 15 Best Practice Guides in 2011, including a completely revised guide on Security Culture which now includes a self assessment culture survey questionnaire. **Best Practice Guides**

We published a specific Guide on "Nuclear Security for Scientists and Engineers" but many of the Guides have direct relevance to the safety and technical community as well as senior management and off site response agencies.

WINS continues to be the only organisation in the world to provide a members' website, where such practical advice based on real life experiences is available free of charge to all members across the world. That's one of the things that sets WINS apart from others; it was established to make best practices available to those accountable for nuclear security; and that is exactly what we do.



This year we completely redesigned the Members Area so that publications and the workshop calendar are readily accessible with just a couple of clicks. We also added a fully interactive interface so that members can leave comments or upload documents that they believe support the work of developing the Best Practice Guides. We added Korean to the seven other languages in which most of our documents are available, as a mark of respect to the Republic of Korea, which hosts the next Nuclear Security Summit in Seoul in March 2012.

We believe that the Compendium will prove a significant contribution to improving the implementation of nuclear security best practices.

The Nuclear Security Summit in March 2012 will bring together over 50 World leaders to review progress against the Work Plan agreed in Washington, DC two years ago. The hosts, the Republic of Korea, has also organised two other related events; the Nuclear Industry Summit for Chief Executives of the Nuclear Industry, and the Nuclear Security Symposium for other organisations that wish to support the goals and ideals of the Summit process. WINS decided in 2011 that it could best support the Summit and associated events by commissioning a special volume of Best Practices drawn from its 25 published Guides in a special Compendium edition that is being printed especially for the Summit. We were delighted to obtain the support of Moleskine®, manufacturers of "Legendary Notebooks", based in Milan, Italy, who agreed to print custom volumes of the Compendium for participants at the events.

We have Clarice Dankers, the WINS Technical Editor, to thank for editing the Compendium and to Raum3 for its design.



Accreditation of WINS Quality Management Processes is seen as an important development in WINS' evolution to demonstrate that WINS is a quality organisation.

We have chosen **ISO 9001** as the most appropriate benchmark and Vesna Gradt, the WINS Finance and Quality Manager, will lead our efforts to become accredited in 2012. Thereafter, we will consider becoming accredited under **ISO 29990:2010**

ISO 29990:2010 is the first standard developed specifically to create a suitable framework for preparing standards in the field of non-formal learning services. Core elements are ensuring the quality and effectiveness of the education or training and improvement of knowledge transfer, whilst also enhancing the transparency and comparability of the range of learning services provided. ISO 29990 will help learning service providers improve their ability to consistently provide quality services, improve organisational effectiveness, and reduce overall business costs.

who has been seconded from the US Department of Energy for the past three years, has made an outstanding contribution to the establishment and success of WINS over the three year period and will be seriously missed. **Harold Eichenholz,** was seconded to WINS from the US Nuclear Regulatory Commission (NRC) for twelve months as a cost free expert.

During 2011 WINS continued its Internship Programme with the addition of three young professionals who contributed to the development of WINS' activities:

Benjamin Katzenberg, a graduate from the New York University School of Law, used his knowledge of international law to help advance WINS' mission.

Laura Pedraza, who finished her M.A. at the Diplomatic Academy of Vienna, worked for WINS in the field of media outreach.

Chris Myers, currently finishing his PhD in Nuclear Engineering, assisted the WINS team in the development and implementation of WINS' Education and Training strategy.



As well as believing it a priority to improve the professional development opportunities for Security Practitioners, WINS also believes in the development of its own staff.

In 2011 WINS organised two Team Building events and offered personal coaching to all staff. The first Team Building event was a twoday meeting and took place from 14–15 April in Pamhagen, Austria. On the first day the staff were invited to take part in a number of outdoor activities whilst the second day was devoted to the discussion of topics relevant to the organisation, such as communication, team work and QMS compliance.

The second Team Building event took place on 15 December in Mauerbach, Austria. This one-day event was dedicated to the discussion of the WINS 2012 Strategy, ISO certification and internal and external communication, amongst other topics. Concrete actions and outcomes resulted from both meetings and have contributed to the optimisation of WINS' processes and work flow.

FINANCIAL PERFORMANCE

The Annual Accounts for 2011 were audited by Deloitte GmbH in January 2012 and found to be entirely satisfactory.

WINS' overall cash position at the end of 2011 was slightly improved over the beginning of the year and total expenditure during 2011 was slightly over 2M Euros.

WINS moved from a cash accounting basis in 2011 to accrual based accounting on the recommendation of the Auditors, because of the increasing complexity of WINS' funding and expenditure.

WINS was also audited by the Canadian Ministry of Foreign Affairs and International Trade in May 2011 and the accounts found to be fully in line with their requirements.

FORWARD STRATEGY FOR 2012

During 2012 our focus will move from the development of Best Practice Guides to other strategic areas that WINS believes are necessary to address in order to help achieve more effective worldwide nuclear security; as depicted in the graphic opposite.

In particular, WINS will work to:

- 1 / Establish the WINS Academy that will provide Professional Development materials for those with security accountabilities, including safety managers, designers, engineers and off-site response agencies.
- 2/ Work with WANO to better understand the interface between nuclear safety/operations and nuclear security with the objective of producing definitive advice based on experience and examining the scope for peer review.

3/ Examine the opportunities for introducing market incentives to encourage Licensees and others to enhance their security based on an all risk approach to investment, insurance and other mechanisms.

4/ Encourage greater transparency of reporting by Licensees and Regulators that helps explain the Corporate Governance arrangements and their effectiveness.

5/ Continue to provide excellent Guidance documents and WINS workshops to share and promote security best practices, worldwide, including the publication of the WINS Compendium.
